The Officer said let me out and the cook said you are going to have to say please. Numerous times the Female officer asked to be let out before she was let out. This all happened in front of inmates. Investigation is on going

Mid-Hudson Region Report:

Mid-Hudson Report: assault on staff at Hudson on the day of the Gov's press release on Juvenile inmates. 1 Officer with a broken ankle, one with a laceration to his elbow requiring stitches, and another with back, shoulder and hand pain. All 3 were out of work. The DA showed up at the

facility the next day demanding to have a copy of the UI. He was denied, and denied entrance. The inmate was given 180 days SHU.

We had an issue out of Downstate during the snow storm last week. Officers were being told that they could not call out "weather related" and had to call in sick if they weren't coming in. Hours later, the facility started calling members and told them to bring in Doctor's notes or they will be AWOL for that day. CSS Cooper was able to get the facility to withdraw the direction and remove the AWOL's.

March 1st, I was informed that an Officer from Otisville committed suicide.

We conducted Step 2's at Downstate, Fishkill and Green Haven. Setting up more step 2's throughout the region. I have recently discovered that there are some labor reps that are many months behind in answering step 2's.

Multiple Q&A's at Albany Training Academy.

We have an Officer locked out with an NOD for insubordination and DOCCS is only asking for 60 days suspension. The case is going to Arbitration.
