I attended a Staffing Review meeting in Albany on behalf of Downstate CF. It bothers me that additional security jobs weren't approved as well as existing temporary jobs that have been active for 17 years were not approved either. I raised the issue that when the housing unit Officer brings a group to chow on the afternoon shift, he leaves the unit with no security coverage.

I attended a meeting with DOCCS along with other board members to discuss issues throughout the state.

We attended Step 2 grievance meetings at Fishkill CF, Otisville CF and Ulster CF. We are currently scheduling more in the region.

In addition, we have attended multiple Q&A's in Albany, pre-arbitration meetings with members and several days of Disciplinary Arbitrations.

It appears that assaults on staff have been increasing in our region despite what the department has reported. I have an issue with the current "electronic" reporting system. When a member files an assault alert on line, I am not receiving an immediate report. I need to have that information asap. There was a recent assault at Fishkill CF where an Officer sustained a possible broken nose and another sustained a shoulder injury. I was waiting on the report and contacted the CSS several times trying to obtain it. The stewards at the facility kept saying that it was sent, so I had Larry Flanagan search the Office and check with NYSCOPBA HQ. I finally found out that it was filed through the website when Toby sent an email containing a compiled lists of assaults throughout the state.
