

I have been in the Department of Corrections for 35 years and I have worked my entire career down back and have been a facility steward on and off for 15 years.



**AFFECT CHANGE:** Through continuous negotiation with DOCCS/Governor's Office, I successfully worked toward policy changes for better equipment: including pepper spray, cell sense, K9 units for contraband detection, ban of hooded sweatshirts for inmates and the removal of canned goods and Glock transition.

**HONOR INPUT OF MEMBERSHIP:** Through member input and regional assistance, staffing numbers are on the rise. I continually pushed for more training, disputed revised directives and procedures (Search form 2077, Directive 4955), addressed concerns regarding K2, cell extraction, body scanners, assaults, post closures, job changes and Justice Center issues.

EDUCATE THE PUBLIC: Through public relations we continue to educate the public and elected officials about the stressors of the difficult jobs we perform. As a result, many Legislators have conducted research and reported on the current state of our prison system leading to meaningful discussions with the Governor's office and the Dept.
