## New York State Correctional Officers & Police Benevolent Association, Inc.

Pursuant to a letter of agreement dated August 10, 2017, and signed by David Viddivo, Treasurer of the New York State Correctional Officers & Police Benevolent Association, Inc., hereinafter referred to as "NYSCOPBA," the American Arbitration Association, hereinafter referred to as the "Administrator," agreed to conduct an Election of Officers.

Twenty-Two Thousand Four Hundred Forty (22,440) ballots were mailed to eligible voters on Friday, August 4, 2017.

NYSCOPBA provided the Administrator with a list of persons who were eligible to vote. During the course of the election an additional One Hundred Eleven (111) ballot packets were mailed at the request of NYSCOPBA members.

To be counted, ballots had to be received by the Administrator no later than 5:00 PM on Wednesday, September 27, 2017. The administrator received Six Thousand Seven Hundred Eighty-Five (6,785) ballots prior to the deadline. Some ballots were set aside due to eligibility issues. A breakdown of the return is listed as follows:
