#### **ARTICLE VII DUES**

The dues for active members shall be fifteen and 50/100 dollars (\$15.50) per pay period, payable through payroll deductions. Commencing January 1, 1999, the dues for active members of the Association shall automatically be increased by the same percentage as the increase in salary of members of the collective bargaining unit. No such increases in dues of the Association shall be effective until the effective date of each such increase in salary of members of the collective bargaining unit. The Executive Board shall compute and announce the amount of the revised dues whenever there is to be an increase in dues based upon an increase in salary. Dues for associate members shall be twenty five dollars (\$25.00) per year. There shall be no dues for honorary members. Dues for associate members and honorary members shall be fifty dollars (\$50.00) per year. Any future dues increase to the retiree dues) will be made through a motion/committee recommendation with final approval of the Executive Assembly. The dues obligation shall be waived for any member who has been taken off their respective agency's payroll due to any of the following: Suspension from a Notice of Discipline; Military Leave; Sick Leave; FMLA; or Workers' Compensation Leave, until such time as the member is returned to the payroll or their employment is terminated.

#### The wisdom of the proposed amendment

- The associate members' dues have not been increased since the inception of NYSCOPBA in 1999. The cost to maintain retiree benefits is costly and this increase brings the chapter closer to being financially solvent in the event the upcoming federal litigation has a negative effect on the organization.
- Is to have the retiree chapter financially solvent in the event that the pending federal litigation has a negative impact on the organization. It also assures that active members maintain stock in the retiree chapter with their contribution and allows the Executive Assembly the power to make sound financial decisions in relation to their future once they enter retirement.
