Coxsackie - An inmate attacked staff with the arm of a chair that was broken off. 1 Officer received a concussion when he was struck in the head.

Downstate - Multiple Q&A's are scheduled next week for a Use of Force incident that occurred in 2017. The Officers and a Sgt have been on administrative leave for quite a while.

Eastern - No major issues reported

Fishkill - Officer Rolle passed away from an apparent heart attack. May he Rest in Peace.

Green Haven - A trip with 15 inmates was sent to Fishkill CF RMU with only two (2) Officers. This trip had 5 inmates classified as CMC-A. It is believed that the trip was sent this way to avoid using 2 vans which would require more Officers.

Greene - Inmate's death caused an issue at the facility. The department could have made it known sooner that no staff were involved and it appeared that the inmate died of cardiac arrest.

Hudson - Tablets have been issued at the facility. The Kiosks do have cameras in them. Posts are being closed daily to avoid the payment of overtime at the facility.

Otisville - No major issues reported

Sullivan - Visitors are being caught attempting to smuggle drugs into the facility. A lot of weapons are also being found in the facility.

Ulster - Still finding contraband on inmates arriving from Rikers Island. Does DOCCS have a plan of action?

Wallkill - The is an Officer assigned to the Sally Port Tower and the 3-11 shift, but no Officer is assigned to the Sally Port. The Officers that are bringing vehicles into the facility are being told to frisk the vehicle themselves. It is also reported that Supervisors are being directed to open water/drink bottles in order to smell the contents.
