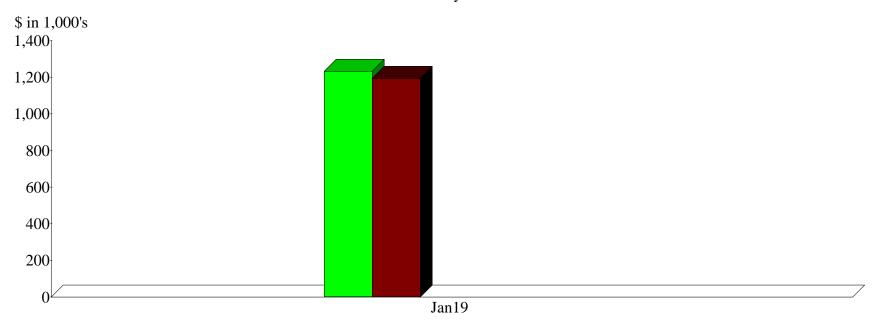

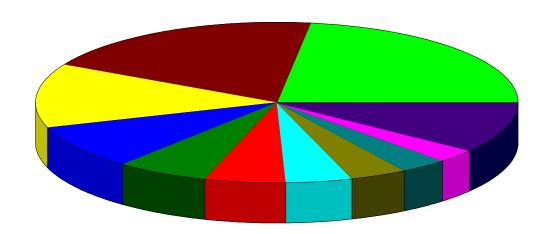

#### Income and Expense by Month January 2019



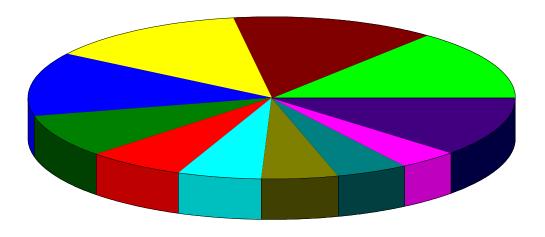
