RE: NYU Langone Health Hospitals' Participation in The

Empire Plan Provider Network May Expire July 1, 2019

This memo is notification that recent contract negotiations with NYU Langone Health Hospitals have been unsuccessful to date; therefore, unless further negotiations lead to a contract agreement, this hospital network will be considered out-of-network for services rendered on or after July 1, 2019. Hospitals include Tisch Hospital, Rusk Rehabilitation at NYU Langone Ambulatory Care Center, NYU Winthrop Hospital, NYU Langone Orthopedic Hospital, NYU Langone Hospital-Brooklyn and NYU Langone Brooklyn Endoscopy and Ambulatory Surgery Center. Letters notifying affected members (those living within 30 miles of one of these facilities and/or those who have received services at one of these facilities within the past year) will be issued on June 1st.

Should negotiations fail, the following services will be the **only** services paid on an innetwork basis:

- Cases of emergency
- If no in-network hospital exists that can provide the services required
- If a network hospital is not available within a 30-mile radius from member's home
- For continuation of care for pregnancy or health risk
- For any services that were previously preauthorized

Except for the circumstances above, all services will be covered on an out-of-network basis, as follows:

Covered services (other than those above) shall be reimbursed at 90 percent of charges and the member will be responsible for the additional 10 percent of the billed charges up to the annual coinsurance maximum amount. The annual coinsurance maximum amount on July 1st is \$3,750 for enrollee, \$3,750 for enrolled spouse/domestic partner and \$3,750 for all enrolled dependent children combined for non-network hospital services. For members in titles equated to salary grade level six or below, the coinsurance maximum will be \$1,875.

Due to network termination of these facilities, the following may also occur:

- patients may be refused treatment for non-emergency services or elective treatment at any of these facilities;
- although these facilities cannot refuse emergency treatment to a patient, once the patient is stabilized, they might choose to transfer the patient to another facility;
- patients may be required to make payment up front, before services are rendered at any of these facilities;
- patients may be required to sign a guarantee of payment before receiving services, which may include an outline of a payment schedule, as well as interest that can be charged on any outstanding balance; and
- these facilities will no longer be required to bill Empire Blue Cross/Blue Shield directly so enrollees may be responsible for filing claims to obtain reimbursement.

Therefore, due to the out-of-pocket costs members will incur using one of these NYU Langone facilities, members seeking services should utilize a participating hospital. A list of alternative in-network facilities, is below:

Members who utilize an NYU Langone facility beginning 7/1/19 will be issued payment for covered services directly and it will be that member's responsibility to pay the facility.

Members currently receiving services from an NYU Langone facility or who are scheduled for treatment at one of these facilities should contact Empire BlueCross BlueShield toll free at 1-800-495-9323 (Monday through Friday between the hours of 8:30 am and 5:00 pm). Customer service representatives will be happy to answer any questions they may have, as well assist them in selecting a facility that is in-network.

Please note that these changes have no impact on the Medical/Surgical Program administered by United HealthCare. However, remember that paid-in-full services for anesthesia, radiology or pathology are only available at in-network hospitals. Members may continue to use the same Empire Plan participating physicians or seek services of non-participating providers using the Basic Medical benefits. If a member is using a provider who has admitting privileges at both an NYU Langone facility and other innetwork hospitals, that member should ask the provider for admission into the innetwork hospital instead of admission to one of the NYU Langone facilities.

Please share this information with your membership; and I will keep you informed of ongoing negotiations.
