Imam Dawoud S. Adeyola Re: Recommendations for DOCCCS Muslim congregate services

Sir:

Peace and greetings to you, and prayers during this difficult time

In follow-up to our conference call with DOCCS officials this morning, I am writing in order to clarify our position on the above. Encaptioned Matter.

In response to the local, national, and global threat to public health and safety posed by CoVid 19 (the Corona Virus), the Majlis Ash-Shura of New York State formally recommends that all congregate Muslim services in the prisons of the state be suspended until further Notice, subject to daily and weekly review.

Our recommendation meets the primary objective of Islamic canon law, which is the preservation of human life. Further it is consistent with the current recommended practices of mosques and Muslim places and houses of worship in Mecca and Madinah, Arabia, as well as throughout the United States of America, and specifically in the tri-state area of New York, New Jersey, and Pennsylvania.

Further, we do not believe that any suggestions for "social distancing" or separation within such congregate services are appropriate under any circumstances, or at any time.

We appreciate this opportunity to exercise our ongoing partnership, cooperation, and consultation with DOCCS officials, in the interest of all parties. Please call upon us at any time.
