- I. DESCRIPTION:** Marcy Correctional Facility is classified as a medium security correctional facility and is located in the Town of Marcy in Oneida County. This facility is used for the general confinement of males 18 years of age or older.

Marcy Correctional Facility has a special housing unit.

- II. FUNCTIONS:** Marcy Correctional Facility offers Aggression Replacement Training (ART), Comprehensive Alcohol Substance Abuse Treatment (CASAT), Residential Substance Abuse Treatment (RSAT), an Alternate Drug Treatment Program (ADT), a Medication Assisted Treatment (MAT) Program, academic education, vocational training, industrial training, substance abuse programming, counseling, transitional services, and a “low risk” sex offender program.

Marcy Correctional Facility serves as an alternative Relapse Program placement for male temporary release participants.

The Office of Mental Health (OMH) operates a Prison Based Sex Offender Treatment Program at Marcy Correctional Facility.

Central Pharmacy Operations are located at Marcy Correctional Facility.

Marcy Correctional Facility is classified as Mental Health Service Level 2, as defined in Correction Law, Section 2 (28).

Marcy Correctional Facility also has a Residential Mental Health Unit (RMHU) which is classified as maximum security. The RMHU is jointly operated by the Department and OMH as a Residential Mental Health Treatment Unit for inmates with serious mental illness, as defined in Correction Law, Section 2 (21). The RMHU is classified as Mental Health Service Level 1, as defined in Correction Law, Section 2 (27), with a Residential Crisis Treatment Program (RCTP) consisting of four observation cells. The RMHU program model is further defined in 7NYCRR 320.2.

Marcy Correctional Facility operates a DOCCS Regional HUB Recycling Center that provides industrial training. This operation is capable of handling, processing, and marketing recyclables received from other DOCCS facilities as well as other agencies and municipalities within their region.

- III. CRITERIA:** To be eligible for placement in general confinement, an inmate must be designated medium security or less.

- IV. PHYSICAL ENVIRONMENT:** Housing units at Marcy Correctional Facility consist of dormitories. The special housing unit and RMHU consist of single cells.
