Pursuant to a letter of agreement dated September 28, 2020, and signed by Frank Gilbo, Treasurer of the New York State Correctional Officers & Police Benevolent Association, Inc., hereinafter referred to as “NYSCOPBA,” the American Arbitration Association, hereinafter referred to as the “Administrator,” agreed to conduct a Runoff Election of Officers.
